OPENING PLENARY The Current Context

As communities across the country grapple with the urgent crises of mass incarceration and the growing problem of opioid overdose deaths, there is increasing interest in alternative approaches to securing public health and safety. These discussions take on the greatest urgency in municipalities which are continually challenged by major public health and public safety issues related to substance misuse, mental health, and poverty. In places across the country, many “traditional” approaches have proven ineffective at addressing these problems, while often leading to unjust and biased outcomes for marginalized communities.

In this opening plenary, speakers discuss how many cities and counties in the U.S. are now experimenting with innovative programs, partnerships, and approaches to reduce the scope of criminalization, securing health and safety, and advancing justice and equity for everyone.

MAKING DIVERSION WORK

Anchoring the Process in Community Public Safety Groups

Community and public safety groups play a crucial role in the development and implementation of public health and public safety interventions. Some models bring law enforcement and community members together around a common goal in ways that are very different than their previous relationships to one another. Where and how are community public safety groups collaborating with law enforcement to develop diversion programs? What are the benefits and limits to such an approach? How do community public safety groups see diversion work fitting into efforts to end mass incarceration and the war on drugs?

This workshop will explore the ways in community public safety groups are working to address issues of public safety, racial disparities in arrests, and reorient governmental responses to poverty, mental health, and substance use.

LUNCH PLENARY

Community-Driven Diversion: Albany LEAD

In Albany, NY, the city's innovative Law Enforcement Assisted Diversion (LEAD) program is an innovative approach to advance health and safety in the community. In LEAD, individuals who would typically be arrested and jailed for low-level offenses often driven by psychosocial challenges are instead diverted to harm reduction-based case management and outreach services. Albany was the third City in the nation to launch LEAD, the first city on the East Coast, the first to advance innovations including partnerships with medical providers, as well as the first to develop and incorporate a Community Leadership Team, and a community-oriented data workgroup.

In this plenary, speakers will share how Albany LEAD came about and the central role that community engagement played in both creating the context to make LEAD possible, but also ensuring that it remains true to its objectives, grounded in community accountability and striving to continuously improve.

BEYOND DIVERSION

Municipal Strategies for Preventing Overdose Deaths and Promoting Healthier, Safer Communities

There is a growing understanding that the criminal legal system is not the right mechanism to respond to the health crisis of opioid addiction and overdose deaths; indeed, many law enforcement leaders themselves have said that communities “cannot arrest their way out of the problem.” While pre-arrest and pre-booking diversion programs play an important role, alone they are not enough, and communities are looking for additional innovations to strengthen public health and public safety. What are other strategies being used or tested to save lives and improve health and safety? What are the opportunities and challenges for systemic reform? In this session, attendees will learn about innovative approaches to advance health and safety, including New York’s Drug User Health Hubs, new approaches to Medication Assisted Therapy (MAT), expansion and integration of harm reduction services, and Comprehensive User Engagement Spaces.

MAKING DIVERSION WORK

Funding at the Intersection of Public Health and Public Safety

To make diversion programs work, it often requires collaborations with systems that intersect and make up the social safety net, like healthcare (including mental health, substance use), housing, education, etc. It also requires an intersectional approach to community engagement—such as when community public safety groups collaborate with law enforcement to build diversion practices.

What opportunities do these intersections create for funding and reinvestment? How can municipalities maximize the potential of these intersections to secure funding to support diversion and systemic change?

In this session, participants will hear from representatives from government, private foundations, and businesses about how municipalities can identify resources to support innovative, community-based diversion programs. Speakers will explore how Albany’s LEAD initiative was

developed and implemented to avoid duplication and amplify existing resources; how NY's Delivery Reform Incentive Payment (DSRIP) Program was used to fund LEAD in Albany; and how pre-arrest diversion and other public health-public safety partnerships intersect with the goals of the healthcare system.

BEYOND DIVERSION

Legislative and Policy Reform

While municipalities advance local reforms like pre-arrest diversion, it's critical to keep in mind that local realities are shaped by a broader policy context. What would pre-arrest diversion look like if the drug war was over, or if sex work and drug possession were decriminalized? If health care and drug treatment were widely available and destigmatized, would the nation be facing an overdose and addiction crisis of the same scale?

What reform steps are needed in state legislatures to end mass incarceration and the war on drugs? What are the obstacles to reform? How can local work be leveraged to

support statewide and even federal change? In this panel, community stakeholders and elected officials discuss their efforts for legislative reform at the state level to strengthen health, equity, and justice for everyone.
