Support for signing this critical legislation continues to grow as individuals and organizations across the state demand further action in response to the crises unfolding in local jails and state prisons under your Administration.

The coalition of groups represented here has come together to support Section H of the Omnibus bill, which reforms the State Commission on Corrections. Our groups come from across the state, including Buffalo, Rochester, Syracuse, Albany, the Hudson Valley, NYC, Long Island, and more. We represent a diversity of sectors, constituencies, and perspectives, including faith-based groups (Christian, Jewish, and Muslim organizations), unions, academic institutions, re-entry providers, legal groups, mental and physical health care organizations, immigrant rights organizations, LGBTQ+ groups, small businesses, youth organizations, and more.

We know you understand the urgency of this situation. The recent New York Times <u>investigative</u> report about the crisis in our state prisons underscores the problems at hand. The Omnibus package is an important and necessary step to address these humanitarian problems.

## New York Community Organizations Support Making the State Commission of Correction Accountable to Its Mandate

(S. 8415 – Salazar / A.8871 – Dilan) – Section H of the 2025 Omnibus Corrections Bill

When a person is incarcerated in New York, the conditions of confinement must meet basic constitutional requirements. But across the state – from Buffalo to New York City and Greene County to Suffolk County – many jails and prisons are plagued by human rights crises, terrible conditions, gross mismanagement, extreme violence and routine constitutional violations.

In New York City, the Rikers Island jail complex has a long and well-documented history of torture, abuse, violence, and a lack of safety for both incarcerated people and staff. The jails in Greene, Dutchess, and Onondaga counties, and also many others consistently put incarcerated people at grave risk of harm.<sup>i</sup>

State prisons are no different. The gruesome killings of Robert Brooks and Messiah Nantwi by correctional officers at Marcy and Mid-State Correctional Facilities is a recent stark and gut-wrenching example of the deadly and dangerous conditions incarcerated people face in New York state prisons.

The State Commission of Correction (SCOC) is an independent body mandated with the constitutional authority to ensure that correctional facilities across New York – all local jails and state prisons – are "safe, stable and humane." The commission also has the power to shut down correctional facilities found to be out of compliance. But for more than 20 years the SCOC has consistently failed to meet its responsibility. In the final week of the 2025 legislative session, Senator Julia Salazar and Assemblymember Erik Dilan introduced and passed the Omnibus Corrections Oversight bill (S. 8415 – Salazar /A.8871 – Dilan).

Section H of this omnibus bill includes (S. 856)-Salazar/ (A.2315)-Gallagher, which aims to fix the SCOC by bringing greater accountability so that it meets is mandate with regards to jails and prisons throughout the state.

This legislation will expand and diversify the State Commission of Correction to ensure it meets its oversight mandate:

- Expanding the Number of Commissioners: The bill suggests adding six new
  commissioners to the SCOC (expanding it from three to nine), distributed among the
  governor, the state senate, the state assembly, and the <u>Correctional Association of New York</u>
  (CANY), an independent oversight organization. The governor would retain three
  appointments, and the senate, assembly, and CANY would each select two commissioners.
- **Diversifying Appointments:** The appointments would guarantee diversity in background, requiring commissioners who have experiences in public health, behavioral health care, indigent legal defense, prisoner's rights litigation, and formerly incarcerated individuals.

We, the undersigned, call on Governor Kathy Hochul to immediately sign the Corrections Omnibus Bill (S. 8415 – Salazar /A.8871 – Dilan) into law, which will through Section H expand and diversify the State Commission of Corrections to ensure that all jails and prisons comply with minimum standards and constitutional obligations – otherwise, the SCOC is obligated to shut them down to prevent unsafe conditions, injuries, and deaths.
